Scholarships are available to undergraduate students attending accredited universities, to technical school students, and to students seeking adult education in their career fields. (Please refer to eligibility requirements listed below.)

Deadlines:

May 1 and October 1 (High school seniors are not eligible for the October 1 deadline.) Complete applications must be received or postmarked by the deadline. Incomplete and late applications will not be accepted. No exceptions will be made to this rule.

Award Restrictions:

Applicants must permanently reside in Lincoln, Pike, St. Charles or Warren counties in Missouri.
 Funds are for on-campus expenses only - such as tuition, books, and campus housing.
 Scholarships will be awarded in an amount not to exceed \$1,000 per academic year and exceed \$2,500 per academic career.
 Scholarships are not renewable. Applicants must reapply until they reach the maximum award per academic career.
 Students who choose to reapply must submit a COMPLETE application. Previous applications are not kept on file.
 Scholarships must be applied to one semester (they cannot be divided between two or more semesters).
 Scholarships are available for Undergraduate and Adult Education/Vocational Training students attending accredited schools.
 Scholarships are not available for tuitions to private grade schools or high schools, or for graduate students.

Selection & Notification Process:

Recipients are selected on the basis of educational commitment, community service and financial need.
 Scholarship award recipients will be posted on **www.cuivre.com** on **June 10** and **November 18, 2010**. Scholarship checks will be written to the educational institution. Additional copies of this application are available online at **www.cuivre.com**.

- Complete pages 2 and 3 of this application.
- Provide a typed, one or two page essay highlighting your achievements, school activities, community service and career plans.
- A complete copy of your Student Aid Report (SAR). The SAR is the official record that your Free Application for Federal Student Aid (FAFSA) was processed. (For details on the FAFSA visit www.fafsa.ed.gov)
- Provide two current letters of recommendation from counselors, teachers, employers or other non-relatives. Letters must be written within 12 months of application date.
- Provide a current **official** high school or college transcript. GPA must be 2.5 or higher.
- Provide a professional photograph of yourself for use in the *Rural Missouri/Current Times* and local press releases.

Eligibility Requirements for Adult Education or Vocational Training Students (Graduate students are not eligible.)

- Complete pages 2 and 3 of this application.
- Provide a typed, one or two page essay highlighting your achievements, community service and career plans.
- Provide two current letters of recommendation from counselors, teachers, employers or other non-relatives. Letters must be written within 2 months of application date.
- Provide a professional photograph of yourself for use in the *Rural Missouri/Current Times* and local press releases.
